4. BELLA VISTA reserves the following rights in relation to any goods provided to the applicant by BELLA VISTA, until all accounts owed by the applicant to BELLA VISTA are fully paid:
  - a). legal ownership of the goods;
  - b). to enter the Applicant(s) premises (or the premises of any associated company or agent where the goods are located) without liability for trespass or any resulting damage and retake possession of the goods; and
  - c). to keep or resell any goods repossessed pursuant to (2) above;

If the goods are resold, or products manufactured using the goods are sold, by the Applicant, the Applicant shall hold such part of the proceeds of any such sale as represents the invoice price of the goods sold or used in the manufacture of the goods sold in a separate identifiable account as the beneficial property of the credit Provider and shall pay such amount to BELLA VISTA upon request. Notwithstanding the provisions above BELLA VISTA shall be entitled to maintain an action against the applicant for the purchase price and the risk of the goods shall pass to the Applicant upon delivery.

I/We acknowledge that if the account is overdue, BELLA VISTA at its discretion, reserves the right to refer the account to a Mercantile Agency for collection and I/We agree to be responsible to meet all reasonable costs & commissions incurred in employing the said mercantile agent to collect the overdue account.
